On Monday, Nov. 11, both libraries will be closed for Staff Day. We have a full day of activities planned. The morning will include staff recognition and state of the library presentations. The afternoon will include ZingTrain presenting an interactive workshop around the topic of Internal Service & Energy Management.

Paranormal Investigation at the Farmington Library

We had 33 people in attendance. Faren gave a great presentation on the history of downtown Farmington and how to use the equipment in the ghost hunting kits that are part of the Library of Things. The upper and lower areas of the library were investigated and there was some evidence of the paranormal. One group communicated with a ghost of a child named Sam by the puppet playhouse in the Children's area and the ghost of a cat named Leon. Another group used the SLS app on the iPad and caught the ghostly image of a tiny person in the nonfiction stacks that then reached out and grabbed a participant's hand! Another group kept getting references to cheese and we later found out there was a cheese factory on the land the library sits on now. A lot of



people asked if we could do the event again next year, so hopefully this will not be the last investigation.
